**Explanation of Responses:**

- These securities are held of record by Annox Capital, LLC ("Annox"). The reporting person, who is a member of the issuer's board of directors, is the managing member of Annox and has sole voting and investment power over the securities held by Annox and as a result may be deemed to have beneficial ownership over such securities.
- Each share of the issuer's Series F Preferred Stock will automatically convert into 1 share of the issuer's Common Stock immediately upon the closing of the issuer's initial public offering ("IPO") and has no expiration date.
- Each share of the issuer's Series G Preferred Stock will automatically convert into 1 share of the issuer's Common Stock immediately upon the closing of the issuer's IPO and has no expiration date.
- The option is fully vested and exercisable.
- The option vested as to 33.333% of the total shares on January 29, 2016 and then 2.778% of the total shares vest monthly thereafter, with 100% of the total shares vested and exercisable on January 29, 2018, subject to the reporting person's provision of service to the issuer on each vesting date.
